Product delivery: The owner (consignor) is responsible for delivering products to Morsel Munk and all associated costs.

Picking up unsold items: A reminder will be emailed to the owner to pick up unsold items (or sent via United States Postal Service if the owner [consignor] does not have email). **ITEMS MUST BE CLAIMED WITHIN 10 CALENDAR DAYS OF THE NOTIFICATION OR THEY WILL BE DISPOSED OF OR SOLD AT MORSEL MUNK'S DISCRETION, WITH NO REIMBURSEMENT TO THE CONSIGNOR.** When picking up items without our reminder, please give us 24 hours notice. Morsel Munk is not responsible for notices lost in email (or stuck in spam folders) or lost by the United States Postal Service.
