

## MJK PERFORMANCE RESTRICTION ON E-COMMERCE & INTERNET SALES

- 1. No Authorized Dealer, Third-Party Reseller or their affiliates shall advertise, sell or offer for sale any Products by means of the Internet, including websites, mobile applications and third party marketplaces (collectively "E-Commerce"), without the express written consent of MJK Performance, or its authorized representative, through an E-Commerce Authorization.
- 2. No Authorized Dealer or its affiliates shall sell Products to another individual or company ("Third Party Reseller") for the purposes of advertising, selling or offering for sale any Products by means of the Internet, including websites, mobile applications and third party marketplaces unless the Third-Party Reseller has first obtained from MJK Performance, or its authorized representative, an E-Commerce Authorization.
- 3. For purposes of clarification, the intent of the above two paragraphs is to preclude all individuals or businesses from advertising, selling or offering for sale any Products by means of the Internet unless the individual or business has the express written consent of MJK Performance, or its authorized representative, in the form of an "E-Commerce Authorization. This includes direct customers of MJK Performance and third party resellers who acquire Products from another business.
- **4.** For purposes of these restrictions, third party marketplaces include, but are not limited to Amazon, eBay, Google Shopping, Sears, Newegg, Rakuten, Walmart and Alibaba. E-Commerce Authorization can be requested via e-mail at INFO@MJKPERFORMANCE.COM.
