IN ADDITION, THERE WILL BE A \$10 FEE FOR GEAR THAT IS RETURNED UNCLEANED (ASSESSMENT IS BASED OFF THE DISCREPANCY OF STORE STAFF/INSTRUCTORS)**

_____ Lessee further acknowledges that he/she has had proper instruction in the use of the equipment leased and is properly qualified to use the equipment and agrees to assume complete and sole responsibility for use and forever holds lessor free and harmless for anything occurring as a result of use. The undersigned further agrees to accept full responsibility for any injury either to themselves or to any other person and/or for any damage to the property of themselves or other persons that may result through the use or misuse of the leased equipment, or in any manner whatsoever, from the time equipment leaves lessor's premises until it is returned thereto. Lessee further agrees that equipment would not be leased to any other person other than the undersigned lessee. No person may use equipment without first obtaining lessor's prior consent in writing. Lessee further agrees to keep equipment from all encumbrances and for failure to do so or for default of any of the terms and conditions hereof, lessor may take immediate possession of equipment whenever equipment may be found, without being liable for trespassing, and that such repossession shall not relieve lessee of his/her liabilities under this agreement.

Lessee agrees that in the event of any legal action is instituted against lessee under this agreement by lessor, they will pay reasonable attorney's fees and cost incurred in such action.
